## 'Chennai has become preferred sports destination, thanks to Stalin'

In the last three years, under the DMK rule, the Tamil Nadu saw a plethora of international events being hosted and the sports infrastructure developed phenomenally like the renovation of the Nehru Stadium, Mayor Indoor Stadium, Mayor Radhakrishnan Hockey Stadium, the tennis stadium and a slew of swimming pools.

The Tamil Nadu has become a preferred sports destination in the country, thanks to Chief Minister Stalin measures and innovative schemes.

Chief Minister had released nearly Rs 1000 crore for sports development in the past three years when several international sporting events were held in Chennai like the International Chess Olympiad in 2022, WTA (Women's Tennis Association) and ITF (International Tennis Federation) tournaments.

The Asian Men's Hockey championship in 2023, Khelo India Youth Athletic Meet in 2023, the Squash World Cup in 2023 has also put the State on the world sporting map.

According to the press release by the Department of Sports and Youth Welfare, Rs 87.61 crore was spent on giving stipend to 2,738 sports persons who brought laurels to the State by proving their mettle in various national and international events.

A total of 81 international coaches were appointed to prepare the sportspersons for various global and national meets in the disciplines of athletics, swimming, tennis, hockey and squash.

The successful organization of the 44th Chess Olympiad led to Stalin being named the Man of the Year by the United Arab

Emirates based Asian Chess Federation and the international Squash tournament returned to Chennai during Stalin's tenure after 12 years.

Among the various other measures taken by the government for the promotion of sports and encouraging of sporting talents was the provision of jobs for successful sports persons, drawing up the plan and starting work on a world class sports city in Chennai, renovating all stadia and sporting facilities run by the Tamil Nadu Sports Development Authority at a cost of Rs 30 crore. That sports had received adequate support from the government was evident from the final medal tally of the Khelo India Youth Athletic Meet, in which the State came second with 30 gold, 21 silver and 30 bronze.

The state-level event for the Chief Minister's Cup organized in 2023

saw the participation of 3.76 lakh sports persons from 15 disciplines. In Chennai the last stage of events were held at 17 venues where 27,554 winners of the district and regional level meets vied for honours.

For the first time in the country, an exclusive sports and physical education university has been launched in the State, in which even the rural youth are encouraged to take part in sports through the distribution of sport equipment and accessories at a cost of Rs 86 crore under the 'Dr Kalaignar Sport Equipment Distribution' scheme that had benefited 420 village panchayats.

The scheme launched to mark the centenary of M Karunanidhi is expected to ensure that youth in the 10,793 village panchayats also get their sport accessories soon.

## Home-makers' graduation dream becomes a reality

Acquire knowledge, even if you have to go to China for it. The golden words of Prophet Muhammad (PBUH) have been taken in the right perspective by a Holy Quran researcher, author and a speaker Dr Ameer Althaf and the trustees in establishing Advanced Institute for Modern and Moral Science (AIMMS) Community College at Sundarapuram in Coimbatore wayback in 2005.

According to the teachings of Islam, education is very important. The Holy Quran commanded the believers to "Read". And this commandment did not distinguish between male and female believers. Prophet Muhammad's wife Khadeeja, was a successful, highly educated businesswoman in her own right. Prophet Muhammad praised the women of Madinah for their pursuit of knowledge.

Really heartening to hear that about 85 women under the aegis of AIMMS took up their Afzal-ul-Ulama exam including entrance, prelims and finals conducted by Madras University at The New College centre a few days ago. Words cannot express the amount of happiness the women had, which included pregnant women (eight months) besides two others with their one

month old babies belonging to below poverty line families. In fact, they craved to make their graduation dream a reality, come what may. Of course, their family extended full support to them.

Ameer Althaf told this scribe that the pregnant women hired a car from Coimbatore to reach the examination centre in Chennai. Of the total 827 students from across various places in Tamil Nadu, who took up the Afzal-Ul-Ulama exams, ten percent of them were from AIMMS community college. No doubt, the sole aim of AIMMS is to empower women to excel in their career after the course.

Masjid Imams besides school moral science teachers and Aalimas, who completed their Islamic studies pursued Afzal-Ul-Ulama degree course with an intention of doing their PG in Arabic. Definitely, the awareness on education among Muslim women has increased manifold if the 85 women from AIMMS attending the degree exam is any indication.

Thanks to the philanthropists, who were behind the success of AIMMS community college while not to speak of Dr Ameer Althaf's untinted efforts in bringing smiles on the faces of women mostly from the lower strata of the society. Not just this, Ameer Althaf penned the 300 year old

history of Coimbatore Muslims aptly titled 'Pettagam' which was released in 2014 followed by his book 'Athaathigal Thirukkuran Kalai Kalanjiam' in a four part series, which is close to his heart. Undoubtedly, this is a magnum opus for the author.

It may be noted that his research papers on the Holy Quran were presented and published in global forums like Ummal Qura University in Mecca, King Fahd University in Medina, University Malaya, Islamic Science University Malaysia besides universities in Istanbul, Jordan, Qatar, Mali. His four decade central government service and three decade research on Holy Quran made him go places across the globe. Significantly, he became known as an International Holy Quran researcher.

Afsal-ul-Ulama is an undergraduate program in Islamic studies. The program aims to provide students with a strong foundation in Islamic studies, focusing on areas such as Islamic law, history, theology, and philosophy. Typically, the course duration for a B.A. Afsal-ul-Ulama degree is three years, and the minimum eligibility requirement is a SSLC. And AIMMS aim is to make home-makers from poor family background realise their graduation dream.



P. ## Remain vigilant: Palaniswami

Chennai, May 30: AIADMK general secretary Edappadi K. Palaniswami advised the counting centre agents of his party as well as those of the allies to remain vigilant on June 4, the day of counting of votes polled in the April 19 Lok Sabha election in Tamil Nadu.

The agents should not report at the counting centres without identity cards or late and should turn up well in advance, he said in a statement. They should sit at the tables allotted to them. "Those who enter the counting centres should not come out under any circumstances until the results are declared. They should exercise extreme caution," Mr. Palaniswami said.

Leader of Opposition and AIADMK General Secretary Edappadi K Palaniswami on Tuesday said that the people of the state extended their support to the party and voted in its favour to vent their ire against the ruling DMK government.

He gave a clarion call to the counting agents of the party and its allies to remain agile till the declaration of the results on June 4.

The recognised agents should enter the counting centre with appropriate identity cards on time. The agents check whether the counted votes and the number of votes polled and entered in 17 C form are identical, said Palaniswami in a statement.

They have been urged not to step out of their respective counting centre till the final rounds of the counting and declaration of the results.

They should exercise caution and remain alert through the counting, he said and charged that the DMK functionaries are experts in spreading misinformation to create confusion and indulge in malpractice and violence.

Hence, the AIADMK and its alliance parties' agents should be very careful to ensure nothing goes wrong.

If the DMK agents and functionaries indulge in any malpractice, it should be immediately taken to the notice of the concerned officials in the counting centre, said Palaniswami and added that they should exhibit discipline in following the orders from the party high command, candidates and chief agents during counting and accomplish their task to enhance the party cadres, functionaries and leaders' tireless campaign to guarantee the victory in the polls.
